### **Faulty Equipment Citations (FL Statute 316.610 & 316.2935)**

Defendant may provide proof of compliance and pay a dismissal fee of **\$88.00** within the first **30 days**. Or pay the full fine of **\$116.00** within **90 days**. **This reduction does not apply to Commercial Driver's License holders.**

### **Proof of Insurance (FL Statute 316.646)**

Within the first **30 days** the Defendant may provide proof that the insurance was valid at the time of the stop and pay a dismissal fee of **\$10.00** or if the insurance was not valid at the time of the stop, proof of renewal and payment of **\$72.90** may be submitted. Otherwise, the full fine of **\$116.00** is due within **90 days**. **This reduction does not apply to Commercial Driver's License holders.**

### **Failure to Display Registration or Driver's License**

Defendant may provide proof that their registration or DL was valid at the time of the stop and pay a dismissal fee of **\$10.00** within the first **30 days**. Or pay the full fine of **\$116.00** within **90 days**. **This reduction does not apply to Commercial Driver's License holders.**

### **Expired Tag or Driver's License**

Defendant may provide proof of renewal and pay court costs of **\$93.25** within the first **30 days**. Or pay the full fine of **\$116.00** within **90 days**. **This reduction does not apply to Commercial Driver's License holders.**

\*Any citation written for failure to display, expired, or proof **cannot** be paid online or via the phone service.
